

Regulations for Spodsbjerg Tourist harbor

- 1) **Sublet or transfer of a space for others is not allowed.** (permanent rental).
Leaving a space for more than 24 hours. MUST BE NOTIFIED to the harbor master, who then has the right to use the space as a guest space. Where space abandoned for more than 24 hours, take moorings with. Be sure to notify in good time, when space is used again. **Fee for non-cancellation 100,-kr. per. time.** Use of nails and screws in piles and bridges is not allowed, this is nevertheless allowed for rental boats in consultation with the harbor master.
When the vessel is taken up for the winter, remove all ropes and weights
- 2) **Deck-wash in fresh water, is not permitted.**
This could be authorized by picking up / careening
- 3) **15 June to 15 August**
Because our berths are very broad, reserve the harbor master the right, during the above period to bring together for example. 3 ships in 2 places.
Ship calls outside long-lying boats are allowed.
- 4) **Water**
There will be no water on the bridges from: first weekend in November, to the first weekend in March.
- 5) **Waste Container**
Only for kabysaffald from ships! Any other use will lead to demands for payment for emptying of the container. **Police report will be done, if the requirement is not complied.**
- 6) **Barbecue spot**
Grill pitches, available at the harbor, can be used by visiting sailors and others. It is not allowed to barbecue on the bridges.
- 7) **Fish waste**
Disposing of fish waste in the harbor, and at the harbor are not allowed. Refer to the rules for the fish rooms. (For Tourists harbor guests only.) Rules of Conduct for fish rooms is available at the port office. Passwords and Admission cards must not be loaned to other than the port guests. **Violations result in a fine or expulsion, see item 14**
- 8) **Use of angler facility**
 - 1) You may only filleted gutted fish. Entrails removed, and the head be cut of the fish before arriving in the harbor.
 - 2) Clean up after yourself.
 - 3) Fish waste are included and is thrown overboard 200 meters from the coast. Are not you going out more, then please ask the harbor master.
 - 4) Please close the windows when you are the last man to leave the room. The door must always be kept closed.
- 9) **Parking**
Parking & driving on the harbor lawns and sidewalks is not permitted without port Officer's permission.
Placing the trailer on the grass nevertheless allowed if the trailer is not locked. (Only allowed on the day of the use of the slipway.)
Parking is reserved for Tourist harbor guests. Others pay fee for parking over 2 hours. There are also paid fees for the use of 2 Spaces.
When parking on the slipway & the yellow stripes, be removed the car of FALCK, the owner's expense.
- 10) **Camping**
Overnight at the parking lot of the period 10:00 p.m. to 7:00 a.m. prohibited. Please refer to the area campgrounds.
- 11) **Dogs**
Dogs must be kept on a lead in the port area.
The dog's owner is obliged to remove any droppings from the dog.
- 12) **Ports sailing**
Sailing in the harbor must be slow. **Generation of unnecessarily turmoil in the harbor would incur a fine or expulsion, see paragraph 14**
- 13) **Closure of facilities.**
harbor facilities will be closed in the period ca. 15th november - 15th March. (**Public toilet**, however, from December 29 to March 1.) Use of the slipway is at own risk. Winter care will not be performed during the period.
- 14) **Whereas in addition the, "Regulation of Danish ports".**
A copy of this is available at the port office.
In infringement of the harbor rules and regulations, and rules for using waste container fee is charged, as set by the Board.
